Purpose of the workshop

NHS Citizen is a project that aims to answer a simple question: what is the best way for NHS England to take into account the views of all the public when it makes decisions? NHS England wants you to be actively involved at its very heart - to help solve long-term problems, deal with ongoing issues, and take part in its decision-making.

As a key part of the local health and social care infrastructure we would like to invite all local Healthwatch to discuss NHS Citizen with us. This will be an interactive workshop with lots of time for discussion and debate. You will have the opportunity to:

- talk to NHS England about the important and unique role of Local Healthwatch

Background

<u>NHS citizen</u> is an innovative approach and we are excited about how it can help provide solutions to Primary Care commissioning, we are seeking to involve people from the wider health and social care field and beyond to work with us.

At the November NHS England board meeting, members formally agreed to implement the NHS Citizen approach to citizen participation in NHS England. There was also agreement to set up a 'task and finish' group that will work with NHS Citizen and others on resolving how NHS England can be an 'exemplar' for public participation in NHS decision making.

The <u>Board paper</u> that was submitted and discussed at the meeting said: "We now need to ensure NHS Citizen is a core part of the way NHS England enables public participation and ensure that it is supported, without seeking to control, to make the step change in public involvement."
